


I hope you enjoy this report, and we all thank you for making GBCHC the largest free clinic in Michigan.



"I was treated with respect, compassion and care..."

I had worked full time my entire life and was fortunate enough to have always had good health insurance coverage. At the age of 54 and after 14 years as a psychiatric social worker, I was laid off. Suddenly, my health care access and costs were my heaviest burden. I wasn't able to have my prescriptions filled or manage several chronic health conditions. I could not find anyone who would take new patients without insurance.

After a referral from Oakland County Health Department, I made an appointment at GBCHC. I didn't know what to expect from a "free clinic" and was more than a little skeptical. Upon arrival I was greeted by Patty, one of the kindest people I have ever known. She treated me like a real person, which I had not felt since I lost my job.

My experiences with the professional volunteers bloomed from there. I was always treated with respect, compassion and care. I received chiropractic care, PT, dental cleanings and exams, and most of my medications at no charge. But what I was really left with after each visit was my dignity and a lighter heart. I vowed that when I was again on my feet, I would contribute and be a part of this worthwhile endeavour.
